**S. R. O. No. 548/2016.**—WHEREAS, the Government of Kerala are of opinion that the minimum rates of wages shall be fixed under the Minimum Wages Act, 1948 (Central Act 11 of 1948) in respect of the employment in Cable Television Network in the State;

NOW, THEREFORE, in exercise of powers conferred by section 27 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government of Kerala, after giving notice of the intention to do so as required by the said section by the issuance of Notification No. 13111/EI/2014/LBR dated 25th February, 2016, published in the Kerala Gazette Extraordinary No. 539 dated 2nd March, 2016 hereby add the above said employment to PART I of the Schedule to the said Act, in its application to the State of Kerala and consequently make the following further amendment to Part I of the said Schedule, namely:—

#### AMENDMENT

In PART I of the Schedule to the said Act, after the entry "Employment in Mid Day Meal Scheme in Schools", the following entry shall be added-namely:—

"Employment in Cable Television Network"

#### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport).

The Government have decided to include the "Employment in Cable Television Network" in PART I of the Schedule to the Minimum Wages Act, 1948, for the purpose of fixing the minimum rates of wages payable to the employees employed in the above said industry.

The notification is intended to achieve the above object.
