In exercise of the powers conferred by Clause (d) of sub section (I) of section 15 of the Payment of Wages Act, 1936 (Central Act 4 of 1936) and in supersession of G.O. (Rt) No. 2183/97/LBR dated 29th July, 1997 and published as S.R.O. No. 634/97 in the Kerala Gazette Extraordinary No. 1101 dated 12th August, 1997 and all previous notification on the subject, the Government of Kerala hereby appoint the Officers mentioned in column (2) of the schedule



below to the Authorities to hear and decide for the areas specified against each in column (3) thereto all claims arising out of deduction from the wages, or delay in the payment of wages, of persons employed or paid in that area, including all matters incidental to such claims.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to appoint Industrial Tribunals in the State mentioned in the Schedule as the authority to hear and decide all claims arising out of deductions from the wages, or delay in the payment of wages, of persons employed or paid in that area including all matters incidental to such claims in supersession of notification issued under G.O.(Rt) No. 2183/97/LBR dated 29th July 1997 and published as S.R.O. No. 634/97 in the Kerala Gazette Extraordinary No. 1101 dated 12th August, 1997.

The notification is intended to achieve the above object.
