S. R. O. No. 163/2020 In exercise of the powers conferred by section 5 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960), the Government of Kerala being satisfied that public interest so requires, hereby exempt all the establishments directly run by the Kerala State Poultry Development Corporation Limited (KEPCO), which comes under the State Animal Husbandry Department from all the provisions of the said Act permanently from the date of publication of this notification in the Gazette.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per section 5 of the Kerala Shops and Commercial Establishments Act, 1960(34 of 1960) the Government may, if they are satisfied that public interest so requires or that the circumstances of the case are such that it would be just proper to do so having regard to the nature and capacity of the establishment, by notification in the Gazette, exempt either permanently or for any specified period, any establishment or class of establishments in any area or persons or class of persons to which or to whom the Act applies, from all or any of its provisions, subject to such restrictions and conditions as the Government deem fit.

The Managing Director, Kerala State Poultry Development Corporation Limited (KEPCO) has requested the Government to grant exemption to the establishments directly run by the Kerala State Poultry Development Corporation Ltd (KEPCO) from all the provisions of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960). Government have considered the request and have decided to grant permanent exemption to those establishments directly run by the said Government Company, from all the provisions of the said Act.

The notification is intended to achieve the above object.
