**S. R. O. No. 120/2018.**—In exercise of the powers conferred by section 5 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960), the Government of Kerala, being satisfied that the public interest so requires, hereby exempt the establishment of Lulookkas Gold Centre, Lulookkas Junction, Mulkam, Calicut from the operation of the

provisions of sub-section (1) of section 11 of the said Act, for a period of one year from the date of publication of this notification in the Gazette, subject to the following conditions, namely:—

(1) Every person employed in the establishment should be provided with all benefits under Labour Laws.

(2) Every person employed in the establishment should be allowed a weekly holiday with full wages as envisaged in sub-section (2) of section 11 of the said Act.

(3) The register of employment under sub-rule (1) of rule 10 of the Kerala Shops and Commercial Establishments Rules, 1961 must properly be kept in the establishment and should be produced before the Labour Officers for inspection as and when requested by them.

(4) Every person employed in the establishment should be allowed interval for rest as envisaged in section 8 of the said Act.

(5) Every person employed in the establishment should be given overtime wages as envisaged in section 7 of the said Act.

(6) The working period of every person employed in the establishment should not be exceeded over ten and a half hours including spread over, as envisaged in section 9 of the said Act.

The exemption granted is liable to be cancelled for violation of all or any of the above conditions.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per section 5 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960) the Government may, if they are satisfied that public interest so requires or that the circumstances of the cases are such that it would be just and proper to do so having regard to the nature and capacity of the establishment, by notification in the Gazette, exempt either permanently or for any specified period, any establishment or class of establishments in any area or persons or class of persons to which or to whom the Act applies, from all or any of its provisions subject to such restrictions and conditions as the Government deem fit. Accordingly, Government have decided, to exempt the establishment of Lulookkas Gold Centre, Lulookkas Junction, Mukkam, Calicut from the provision of sub-section (1) of section 11 of the said Act for a period of one year from the date of publication of this notification in the Gazette.

The notification is intended to achieve the above object.
